**Xeerka Qarsoodiga iyo Ogeysiiska Xeerka Dhimista Shaqada-warqadaha**

Xeerka Qarsoodiga ee 1974 wuxuu u baahan yahay marka aan ku weydisano macluumaad waxaan kuu sheegeyna xaqeena sharciga ee aan u leenahay inaan ku weydino macluumaadka, sababta aan kuu weydineyno maxay tahay, iyo sida loo adeegsan doono. Waa inaan sidoo kale kuu sheegnaa waxa dhici kara haddii aynaan helin, iyo haddii jawaabtaada tahay mid ikhtiyaari ah, oo loo baahan yahay si loo helo faa'iido, ama waajib. Xaqeena sharciga ah ee aan kugu weydiin karno macluumaadka waa 5 U.S.C. 301. Waxaan kuu weydineynaa macluumaadkan si uu nooga caawiyo sidii aan kula soo xiriiri lahayn marka loo eego xiisahaaga iyo/ama ka-qaybgalka diyaarinta canshuurta dakhliga tabarucada ah ee IRS iyo barnaamijyada wacyigelinta. Macluumaadka aad bixiso waxaa laga yaabaa in lala wadaago dadka kale kuwaa oo isku dubarida hawlaha iyo shaqaaleynta goobaha diyaarinta tabarucada ama hawlaha wacyigelinta. Macluumaadka ayaa sidoo kale loo isticmaali karaa in lagu sameeyo xakameyn wax ku ool ah, loo diro waraaqo laguna aqoonsado Isxilqaamayaasha. Jawaabtaada waa ikhtiyaari.
